Roads & Safety Report:

Supervisor Clint Hickman has been reelected to represent District 4. Only 300 people attended the recent MCSO safety presentation. MCSO will be posting a voluntary risk assessment on their website. SCHOA, MCSO and Sun City Fire & Medical all recommend key boxes for residential homes. Should there be an emergency, the key box gives first responders immediate access to the home. Cindy also mentioned two pieces of proposed legislation aimed at the problems of panhandlers and homeless encampments. SB 1022 would prohibit the selling of goods on traffic islands; SB1024 would make camping in a public right-of-way illegal.

Community Leadership Committee:

This committee recently regrouped and is meeting again. John reminded us that Sun City CAN will prepare taxes free of charge.

Other Business:

Ronn reminded us that Arbor Day will be celebrated on March 1st this year.

The money jar was won by Ken Hodgden.
